Welcome to Maine 4-H Maple Sugaring 101! We are excited that you are interested in using the materials from our website. This document is an overview of the three Instructional Guides for youth participating in the program. Each guide is for a different educational unit:

- Unit 1 Woods Work: Navigating maple forests and collecting maple sap for syrup production.
- Unit 2 The Sugarhouse: converting maple sap to maple syrup for storage and use.
- Unit 3 Kitchen and Business: operating a maple sugar product business and creating value added food products.

Each Instructional Content Guide has a table with three columns. The **left column** consists of the learning objectives for the unit. The **middle column** lists the activities and resources for each learning objective, which are: in-person activities at the sugarhouse host sites, activities led by UMaine Extension staff and faculty during virtual learning sessions, and Selected Student Resources (SSR). The SSRs include worksheets, informational resources, and lesson plans for adults to coordinate with kids. Each SSR is labeled with a code that begins with "SSR" and number to indicate the learning unit ("1", "2", or "3"), and a letter (see diagram below). Also, the title for each SSR has a weblink to access the resource.

The **right column** lists citations for resources that align with the instructional content for each learning objective. Citations that align with selected student resources in the middle column are marked in parenthesis with the citation in the right column with the page numbers in the text document (see diagram below).
