



Must meet all BPC licensing requirements

- All Pilots and Co-Pilots must meet BPC licensing requirements:
 - > Commercial or Private License
 - Certified in the Aerial Category
 - > Must also be certified in whatever category/subcategory they plan to make applications under (i.e., Agricultural Plant, Blueberry, Outdoor Ornamental)

Chapter 32: CERTIFICATION AND LICENSING PROVISIONS FOR PRIVATE APPLICATORS

SUMMARY: These regulations describe the requirements for certification and licensing of private applicators.

Must meet all BPC licensing requirements

- Commercial Companies must meet additional BPC licensing requirements:
 - > Spray Contracting Firm License
 - > Insurance affidavit
 - > At least one Master Applicator

Agricultural Producers/Private Applicators must comply with all Worker Protection Standard Regulations (WPS)

Maine Board of Pesticides Control Aerial Application Requirements

- Chapter 22: STANDARDS FOR OUTDOOR APPLICATION OF PESTICIDES BY POWERED EQUIPMENT IN ORDER TO MINIMIZE OFF-TARGET DEPOSITION
 - ID Target Site
 - Site Plan
 - Site-Specific Application Checklist
 - Buffer Zones for Sensitive Areas Likely to be Occupied
 - Wind Speed Limitations
- Chapter 51: NOTICE OF AERIAL PESTICIDE APPLICATIONS
 - Notification
 - Posting
 - Written notice to BPC and Poison Control Center

NOTE: (Chapter 51 does NOT apply to agricultural applications)

Maine Board of Pesticides Control Aerial Application Requirements

- Chapter 29: STANDARDS FOR WATER QUALITY PROTECTION
 - This chapter establishes a 50 foot setback from surface water for mixing and loading of pesticides and requires an untreated 25-foot buffer zone for outdoor terrestrial broadcast pesticide applications near waters of the State.

Must meet all FAA requirements

- Certificated Pilot
- Section 333 Exemption (for UAS over 55 pounds) OR Section 107 Exemption (for UAS under 55 pounds)—certifies aircraft to conduct commercial operations
- Part 137 Certification (to dispense pesticides)
- Part 11 Exemption (to carry hazardous materials)
- Other possible exemptions that may be needed depending on the application:
 - operation from a moving vehicle
 - operation with no visual line of sight
 - operation of multiple small UASs
- Individuals will also be required to complete a final Demonstration and Inspection which includes inspection of the aircraft that will be used as well as knowledge and skill testing of the applicant

Rules and Regs 2024

2023 Rules, Regulations and Policies

- 131st legislature bills
 - LD 2019
 - LD 1770
- New Rules
 - Chapter 20
 - Chapter 41
 - Upcoming: Chapter 50
- New Policies
 - Adjuvant policy
 - Clarification of Distribution policy

Bills – 130st legislature

- LD 2019: An Act To Require the Registration of Adjuvants in the State and To Regulate the Distribution of Pesticides with Perfluoroalkyl and Polyfluoroalkyl Substances
 - Changed the definition of pesticide to include "Spray Adjuvants"
 - "Spray Adjuvants" now defined as any wetting agent, spreading agent, sticker, deposit builder, adhesive, emulsifying agent, deflocculating agent, water modifier or similar agent that is intended to be used with any other pesticide as an aid to the application or the effect of it and that is in a package or container separate from that of the other pesticide.
 - Unlawful Distribution: pesticides contaminated by PFAS and pesticides with intentionally added PFAS (2030 prohibition in Title 38, section 1614)

2023 Bills – 131st legislature

- LD 1770: Resolve, Directing the Board of Pesticides Control to Transition to Electronic Submission of Pesticides Sales and Use Data
- Resolve, requiring the board to adopt rules necessary to implement the transition from paper to electronic format of reports
 - Currently in draft, Chapter 50: Record Keeping and Reporting Requirements
 - Transition period in 2024, required in 2025
 - Waiver if unable to access electronic devices capable of submitting reports
- The board submitted a report to the ACF committee related to the rulemaking and implementation of electronic reporting
- ONLY applies to dealers and commercial applicators

New Rules: 2023

Chapter 20

- Incorporated the Board's policy on positive identification of treatment sites into rule, Chapter 20, Section 7
- Includes a clause that the board MAY use discretion to suspend licensure of individuals, master applicators, or spray contracting firms for 45 days
- Chapter 41 (LD 2189)
 - Updates to the chapter to modernize the rule
 - Incorporates the language plant-incorporated protectant (PIP)
 - Changes training certificate requirements
 - Reduces the amount distributors would need to sell (<1ac)
 - Currently in the Senate likely will not pass

New Policies: 2023

- Adjuvant policy
 - Clarifies that water and colorants are not considered adjuvants
- Clarification of Distribution policy
 - Clarifies the meaning of "distributed in the state"
