It sounds like so far, that is not possible. When might it be? Also, I heard that MMHP has a rapid response test. Is this available for use and will the rapid response capacity be expanded?

From Gary.Fish: Drive up testing is becoming available at CVS, Urgent Care clinics, etc. From Allison Lakin: I'd like to see a cooperative labor and equipment (beyond the MOFGA grower centric equipment) connection be made. With all the extra work people are doing, the time window for summer projects is dwindling and the extra work load is taking away from

other needs. Might there be a rhythm of work where people could share labor, like haying. or retired farms that have useful Farm machinery that might rent, or could work out a payment arrangement for unused equipment.

From Julie Ann Smith: Given the income loss due to COVID-19, how will the state generate the necessary revenue to sustain tax exemption and abatement programs that are critical to farmers? Many farms have to purchase expensive equipment due to lack of labor, and the sales tax paid on a large tractor can be more than what is paid in annual income tax. Will any of these programs, such as BETE and BETR or farm and open space be taken away? Will any new taxes be implemented?
